



ADOPTION CONTRACT for Dogs

This contract is made on (DATE) 05/22/2012, between LAST CHANCE Animal Rescue (LCAR) and the adopter, (ADOPTERS NAME) Suzanne Collora, who acknowledges receipt of the following dog described as PAISLEY, Approx 3 month Old Male Hound mix, Male, Hound / Mixed (short coat), Neutered, Brown/Chocolate with White (DOGS NAME and DESCRIPTION including, Age, Sex, Breed Mix, Alter Status, Color)

In addition, I acknowledge that I am 21 years or older, and agree to be bound by and to comply with the following terms and conditions:

1. I agreed to have this dog examined by my veterinarian **within 5 days**. LAST CHANCE Animal Rescue will not be responsible for any and all medical claims during or after the 5 days has expired. If this dog takes ill, I understand I have two options:
 - a. Take the animal to my vet and proceed with tests and treatment **at MY OWN EXPENSE** or,
 - b. Surrender the animal to LCAR and **the Rescue will determine** whether to treat the animal or euthanize. X SC (Initial here)
2. At my expense, I agree to have the dog examined and immunized annually by a veterinarian and provide proper medical treatments as needed.
3. I agree to provide proper and sufficient food, water, shelter and kind treatment for the dog at all times.
4. I agree to properly train the dog and seek professional assistance if needed.
I agree to make every effort to address any and all behavioral issues that may arise. X SC (Initial here)
5. If for any reason I can't keep this dog, I understand that I **MUST** return him/her to LCAR, and I will not give this dog to anyone else. I understand that under **NO CIRCUMSTANCES** am I permitted to surrender this dog to any animal shelter, pound or another rescue. X SC (Initial here)
6. If I return this dog to LAST CHANCE Animal Rescue for any reason, I will at no time assert any claim, charge or demand of any kind or nature against LCAR for any charges which may have been incurred by me, including but not limited to veterinarian fees, in connection with the animal.
7. If I return this dog to LAST CHANCE Animal Rescue within 60 days of the original adoption, I understand that the adoption fee may be transferred to the adoption of another animal from Last Chance Animal Rescue. I understand that my adoption fee is non-REFUNDABLE.
8. I will not permit the dog to run at large or to become a public nuisance, I will keep some means of identification on the dog at all times, and will immediately retrieve the dog from any public or private shelter when notified that the dog is being held at any such location. In the event the dog becomes lost, I will make every reasonable effort and attempt to relocate and claim the dog.
9. I understand that the information provided to me about the dog that I am adopting may have been received by the LAST CHANCE Animal Rescue from third parties and that LAST CHANCE Animal Rescue does not warranty the accuracy or correctness of such information.
10. I understand that dogs can be unpredictable and that LAST CHANCE Animal Rescue cannot anticipate or insure against unexpected conduct of animals adopted from LAST CHANCE Animal Rescue.
11. I acknowledge that LAST CHANCE Animal Rescue has not made through its agents, volunteers, or employees, any warranties regarding the future condition, health, temperament, or conduct of the dog.
12. I hereby accept the dog **as is** and assume all risks and responsibilities associated with ownership of the dog, including but not limited to injury inflicted on any such persons by the dog, and I hereby fully and completely release, indemnify, and hold harmless LAST CHANCE Animal Rescue or any of its departments, officers, employees or agents from any claim, cause of action or liability of any sort or nature, whether known or unknown, directly arising out of or in connection with the adoption, health, care, or ownership, maintenance, retention, temperament, conduct or condition of the dog. X SC (Initial here)

This contract may be specifically enforceable by the LAST CHANCE Animal Rescue through judicial proceedings, including the right of LAST CHANCE Animal Rescue to recover the dog due to **any** breach of any terms of this contract. I hereby agree that in the event I breach this contract and LAST CHANCE Animal Rescue files suit to enforce this contract or to defend any claim under this contract, that I will pay any court costs and attorneys' fees incurred by LAST CHANCE Animal Rescue in connection herewith.
